<u>Description of activities, technical observations</u>:

A. The Beahrs Environmental Leadership Program

The Beahrs Environmental Leadership Program (ELP) at the University of California, Berkeley, offered a unique learning opportunity for us who are mid-career environmental professionals and decision-makers to gain expertise, enhance skills and broaden perspectives on environmental and natural resource management and leadership. Established in August 2000 with seed funding from UC Berkeley alumni Carolyn and Richard Beahrs, the ELP offers an annual 3-week summer certificate course in Sustainable Environmental Management at UC Berkeley, and coordinates an active and growing Alumni Network. The ELP is part of the Center for Sustainable Resource Development, College of Natural Resources. The ELP also supports post-training collaborative projects with alumni through its Small Grants Initiative.

The ELP at Berkeley seeks to:

- 1. Strengthen the capacities of mid-career and new generations of environmental leaders to: integrate inter-disciplinary knowledge for developing innovative ideas, practices and policies; balance environmental, efficiency and social equity objectives; and facilitate dialogue and problem-solving among diverse stakeholders.
- 2. Foster international collaboration among ELP alumni, their institutions and the University of California, Berkeley on a continuing basis.

The 2007 summer course provided the participants opportunities to interact with Berkeley faculty, renowned leaders, and each other to improve understanding of the complex social, economic and biophysical aspects of sustainable environmental management. Participants were continually challenged to meet environmental goals with policies that also expand economic opportunity and reduce poverty and social conflict. One of the great benefits of the course was to learn, share and live with peer professionals from across the globe — Africa, Asia, Latin America, Europe, Oceania and North America. There were 43 participants from 30 different countries.

The course offered workshops on cross-cutting issues during the first two weeks, followed by parallel sessions during the third week. Workshops combined theory, tools and methods with participant-led case studies and group exercises. Field trips within and beyond the San Francisco Bay Area exposed participants to California agriculture, forestry, conservation and restoration, entrepreneurship and urban environmental challenges.

The cross-cutting workshops included the following:

- (1) Ecological Footprint & Sustainability Workout
- (2) Population, Poverty & the Environment
- (3) Environmental Policy & Pollution

- (4) Building Leadership Skills
- (5) Collaborative Processes for Managing Conflict
- (6) Agroecology & Agricultural Biotechnology
- (7) Emerging Clean Energy Options

The parallel sessions were:

- (1) The Urban Environment
- (2) Rural Communities & Natural Resource Management

For the three of us, we chose Rural Communities and Natural Resource Management Session since it is very relevant to our SANREM project in Southeast Asia.

B. Visit to NCA&T and Virginia Tech

The itinerary for NCA&T included visits to the International Students and Scholars Office (ISSO), the C.H. Moore Agricultural Research Station, the Field Research Demonstration Station, the Biological Engineering program, and the Office of International Affairs. We were given orientation on what these offices are doing in relation to the SANREM CRSP-SEA Project. It should be well remembered that the ISSO through its Director, Ms. Loreatha Graves did the paper works relevant to our visa application.

The Virginia Tech visit included a courtesy call with the administrators of the Office of International Research, Education, and Development (OIRED) led by its Director, S.K. De Datta. A brief meeting was held with SANREM-CRSP Management, namely: Theo A. Dillaha, Program Director; Keith Moore, Associate Program Director; and Deanne Estrada, Communications Coordinator.

We also had a time well spent with Ronald Morse at the VT's Kentland Farms. He explained, together with his graduate student, the activities they are doing in the field, particularly on Farmscaping Technology. Aside from sight-seeing tour and visit to Theo's great home, we also had a short meeting with personnel from the USDA Forest Service Office in Blacksburg. We were given various materials by James Chamberlain, Tom Hammett and Paul Winistorfer which are very useful in our respective stations.

Our visit to the Eastern side of the United States, particularly in the states of North Carolina and Virginia also included educational trip to the North Carolina Zoological Park, Pilot Mountain State Park, the SAS Campus, and the North Carolina State University.

<u>Progress in meeting objectives</u>: Both the two objectives listed above under "Purpose of Trip" were met.
